Usage Instructions

- Application temperature best above 40°F; colder temperatures extend cure rate
- Apply to a clean, dry, frost-free surface
- Apply Liquid Membrane by roller, trowel or high-pressure spray
- Check for any pin holes or voids and recoat if needed; membrane continuity is important
- Use with adequate ventilation, inhalation of vapor during application and cure may cause slight eye and throat irritation
- In case of contact with eyes, lips, or mouth flush thoroughly with water; if irritation persists, consult a physician; do not swallow
- Avoid repeated, prolonged contact to skin
